

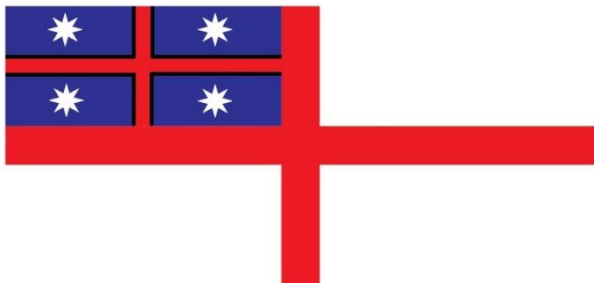

The 1834 Flag and 1835 He Whakaputanga O Te Rangatiratanga O Nu Tireni Document have powerful standing that is why the

information regarding it was hidden from those who had the right to use it...

In 1986 the government tried to remove the 1852 constitution act and entrench the new legislation in the 1952 constitution act. This was an attempt remove more of our rights and protections that safeguarded the people of our country. ( You can see how the

following error occurred due to the 1852 constitution act and the 1952 constitution act being exactly 100 years apart. )

However this back fired and by typing error they repealed (removed) their own 1952 act. Because the 1852 act was found to be false and not imperial law it made THE NEW ZEALAND GOVERNMENT (Corporation since 1984) an UNLAWFUL ENTITY. Make the authorities aware of this when you see them.

Also the people were still protected by the 1835 He Whakaputanga O Te Rangatiratanga O Nu Tirenī.

And that is the basis of the “standing on your card” and with these templates.

The wakaminenga is a gathering of Rangatira o nga hapu. This is the highest authority in testament of your identity and they work with the card issuer.

- 1: The flag is protection (immunity) under British Admiralty Law, British Monarch and is a SEAPASS passport.
- 2: The United Nations recognises the 1834 Flag and 1835 He Whakaputanga document, as does the French Monarchy.
- 3: Your image secures your identity = you own yourself, therefore cannot be under the standing of others.
- 4: The barcode secures your likeness and can be used as a record for travel.

- 5: C-P-S-S-C-P-S-G = Correct Sentence Structure Communication Parse Syntax Grammar.

This is the method of parsing (decoding/reading) the information that forms the power of “standing on the card”. This stuff is complicated and unnecessary, we included it for the advanced human rights members ...but if u don’t understand it like me (monica) then just ignore it coz its a nerdy thing that our tech guy peter put on the card to impress the other nerds.

- 6: The card/document is a vessel of transmission and a contract between you and whoever is reading it.
- 7: The contract was sealed by them accepting the card, tell them it is a contract and they accepted it.  
If it is dealing with the false authorities, then under the four corner rule the card is a court venue convened right there.
- 8: The Diplomatic Immunity we put at the bottom of the card is based on the fact that at birth the NZ GOV trades us on the International Stock Exchange, therefore as international entities we claim our rights to receive Diplomatic Immunity. Even though we detest the NZGOV we included the Diplomatic Immunity to protect you aswell as prove how ridiculous the NZGOV is.

So negotiate your free passage unhindered to your destination as is your right, this new contract supersedes any obligation they may think you have to them.

Please be assertive, but polite! Because they are working under a false illusion of power.

1834 the flag was chosen to be the flag of this land and in 1835 hoisted up the flag pole at Waitangi on the 28<sup>th</sup> of October and the He Whakaputanga document was autographed.

The current false government has actively hidden these facts from everyone. The original document was found by some maori clients from Nga Puhi (who could read Maori) where shown the document during a meeting with a lawyer in a parliament building in Wellington.

The clients were able to read the document and realised what it was, the document was under the glass on top of the lawyer's desk, when the lawyer left they were able retrieve it copy it and later have it translated by Ngapuhi Kaumatua. A copy was given to Karla White from Waitangi- who took it with her to the United Nations in 2004 and it was accepted and sealed by them.

Also last year in 2019 Prince Charles visited Waitangi and upholds the promise that the British Monarchy still honour the 1835 He Whakaputanga and the 1834 flag protection of Maori.
